# The County Safety Committee is going to offer training in "A.L.i.C.E." - This might just save lives:

A.L.I.C.E. is a crisis training program that stands for Alert, Lockdown, Information, Counter and Evacuation. As another form of safety preparedness the A.L.i.C.E. program gives participants insight and response options when encountering an active shooter.

The February 2014 county newsletter featured an article about ALICE training. Since then the Safety Committee has been looking for a training class that could be presented to the County employees in the courthouse. ALICE Training has scheduled for Wednesday, May 28, 2014. Two general sessions will be held in the morning in the Community Room. One will begin at 8:30 and the other to begin at 10:30. In the afternoon the presenter will go to each office in the building and go through a demonstration so each office will have hands on training as to what to do in the office if a situation would arise. A schedule will be set up so offices will know what time this will happen in their office area.

- A Alert. This could be the sounds of gunshot or a visual
- L Lockdown. Only lockdown if you cannot evacuate. Once the door is locked make a plan to counter if the shooter enters your area.
- I Inform. Once you are safe, call 911! Communicate the Shooters Location.
- **C** Counter. If faced with a shooter and you have no other choice, counter. Throw things, make noise, create chaos. You may have the chance to take down the shooter.
- E Evacuate. When safe to do so, remove yourself from the danger zone. Flee the area and go to your rally point. Know your exits. Leave your belongings and go!







#### **Dickinson County Resolution No. 2014-8**

After discussion at several of the Supervisors' meetings and no action taken at the State level, the Board of Supervisors unanimously passed resolution #2014-8 regarding off-road utility and all-terrain vehicle operation in Dickinson County. It is as follows:

WHEREAS Dickinson County has considered the growing popularity and use of Off-Road Utility Vehicles (ORU) and All-Terrain Vehicles (ATV), AND

WHEREAS Dickinson County acknowledges that the operation of such vehicles is regulated by Iowa Code Section 321, specifically Sections 321.20B and 321.234A, which statutes allow counties to designate county roads upon which such vehicles may be operated, AND

WHEREAS the Dickinson County Board of Supervisors, in consultation with the Dickinson County Engineer and Dickinson County Sheriff, has evaluated traffic conditions on all County highways and roadways, determining that off-road utility vehicles and all-terrain vehicles can be safely operated on all such roadways, with the exception of Level C roadways, without interfering with or causing an undue hazard to conventional motor vehicle traffic.

NOW, THEREFORE, IT IS RESOLVED AS FOLLOWS: That registered and properly licensed all-terrain vehicles and off-road utility vehicles may be operated by licensed drivers on Dickinson County roadways (with the exception of Level C roads) from the date of adoption of this Resolution.
